# BY-LAW

**A BY-LAW TO AMEND THE CONSOLIDATED APPOINTMENT BY-LAW  
FOR THE TOWNSHIP OF HURON-KINLOSS**

**WHEREAS** By-Law 2011-70 being the Consolidated Appointment By-Law, as amended was passed by the Council of The Corporation of the Township of Huron-Kinloss on the 18<sup>th</sup> day of April, 2011.

**AND WHEREAS** the Council of the Corporation of the Township of Huron-Kinloss deems it desirable to amend By-Law 2011-70 in regards to updating committee appointments for the Lucknow Downtown Revitalization Committee;

**NOW THEREFORE** the Council of the Corporation of the Township of Huron-Kinloss enacts as follows:
