Part Lot 23, Concession A and part of the Original Shoreline Allowance, Geographic Township of Huron, Township of Huron-Kinloss

The purpose of the application is to permit an increase in the maximum building height on the west peak of a proposed residential building from 8.0 m to 8.8 m when the existing cottage is replaced with a new cottage.

STAFF COMMENTS: David Smith presented the details of the Planning Application for the Committee members. The Committee questioned the shed that is located on the beach. There were concerns with the shed and the dunes that have been removed around the shed and the destruction of the beach area.

The Clerk read a letter for the Committee noting Mr. McKinnon's agreement to enter an encroachment agreement with the Township to permit the continued use of the shed and agreeing to pay for the costs associated with preparation of such agreement.

David Smith stressed how this issue was separate from planning and should not be linked to the application but was brought to the Committee's attention. The Committee questioned ownership of the area the shed sits on and the potential liability the shed created for the Township if something were to happen in it. The Clerk said that an encroachment agreement could be entered and it was Township practice to include a clause for the removal of the shed upon sale of the property. The Clerk noted it is desirable to deal with certain instances as they occur rather than to ignore even though there may be many other "structures" on the beach.

The Committee has concerns with the shed but chose to deal with the structures on the MacKinnon Property and decide on the minor variance request. The issue of the shed will be brought to the General Committee meeting for further direction from Council.
