Mr. Pearson will be in attendance for annual reporting on the Water Quality Monitoring Programs, Septic Re-Inspection Program Cycle 2, Year 2 and Part 8 of the Building Code.

Point Clark Water Quality Monitoring Report

Action: Mr. Pearson noted concerns with elevated E.coli at Site 8 that has been consistent over past years. A further study can be conducted to pin point the concern. B.M. Ross will prepare a budget proposal for Council's consideration.

#### Pine River Water Quality Monitoring Report

Action: Mr. Pearson noted that sites PR17 & PR18 still show increased levels of Phosphorus. A study in 2013 & 2014 was previously completed at PR17 & PR18 and the landowners did participate. However, the numbers still remain high and it was left that OMAFRA would work with the landowner. There has been nothing reported back to the Township regarding this matter. The Committee requested staff arrange a meeting to consult with OMAFRA again. There were noticeable spikes in E. coli at site PR37 along the Royal Oak Drain. B. M. Ross will send out letters making landowners in that area aware of the concern.

#### Septic Re-Inspection Program

Action: Mr. Pearson outlined the 2016 septic re-inspection program. There are 65 properties subject to mandatory inspections under the Source Water Protection Program and there are currently 2 in violation which will be a focus for 2017.

3.2 County of Bruce Economic Development

They will be in attendance to present an update on the initiatives for the Bruce County Economic Development Department.

#### Presentation

Action: The staff from the County of Bruce Economic Development Department outlined the details in the presentation for the Committee. They noted that a partnership in the Business to Bruce Program would require \$15,000 in the budget for 2017. There was also further discussion regarding the horse drawn carriage community and the County supporting their methods of business and development through Planning and Economic Development to locate outside business and industry outside the hamlet areas.

The County staff reported that over 160,000 people had visited Parks Canada in Tobermory. While Bruce County is definitely on the map this has led to some concerns on managing traffic and people. The County is working with Northern Bruce Peninsula and also working on promoting other areas of the County to encourage spreading the visitors throughout the County of Bruce.

They will be in attendance to provide an update on the Campbell Street West Drainage and Road Improvement Project in Lucknow

#### Presentation

Action: Brian Knox and Lisa Courtney presented details on the project. The preferred option is Alternative One which involves installing conduit at the western edge of arena property, south to ball diamond and then east to ditch south of Willoughby. This proposal encloses the open ditch along south side of Campbell Street, and replaces and moves culverts under Campbell Street. There will also be installation of some new local storm sewer on Campbell Street. The drainage only for Alternative One will have an approximate costs to be shared of \$425,000. The road re-construction work will also cost \$425,000 of which the Township portion of the cost will be approximately \$115,000. Next steps are to hold a public meeting to discuss project, alternative solutions and impacts. Then finalize selection of the preferred alternative, finalize the Class Environmental Assessment (EA) and issue notification. The public meeting for the Class EA is scheduled for January 26<sup>th</sup>, 2017. The Committee requested B.M. Ross ensure the system is adequate to take any drainage if a development were to occur on the "Brindley Property". There are benefits to the Lucknow Sports Complex and the Lucknow Fire hall resulting from this project.

The Committee requested Ashfield-Colborne-Wawanosh (ACW) be approached for consideration of cost sharing for the drainage project.
