4. Delegations

4.1 Curb Side Pickup of Yard Waste in Lucknow 7:00 p.m.

Norm Morris, Alvery Hayes, Delores Sokoloski

The delegation will be attending to discuss the removal of curb side pickup in Lucknow, the street sweeper and have requested the job description of each "town works employee". We have also received a petition with 230+ signatures supporting "reinstate curb side pickup of yard waste in Lucknow."

Staff Comments: The Director of Public Works will not be in attendance at the meeting but provided a report at the May 2nd, 2016 Committee of the Whole meeting regarding curbside pickup and boulevard damage. The Director of Public Works will provide a further report at the June 6th meeting based on Council's direction.

Norm Morris spoke first and noted concerns about lack of lawn maintenance after winter snow plow damage and stopping the yard waste pick up. Mr. Morris clarified that he is not concerned with a job description of the public works employees. He requested that the lawn maintenance and repairs be initiated by the Township and questioned if staff check for damage in the spring so repairs could be made.

Delores Sokoloski noted she was attending to speak about discontinuing the village leaf and yard pick up to the residents of Lucknow. She noted that this decision has put Lucknow residents in the difficult situation. Many don't drive, nor have the ability to get their bundles to the depot or end up paying others to do it. The materials are difficult to put in personal vehicles. She requested details on the time and cost spent cleaning up the depot. The decision to stop this has resulted in a lot of upset residents. She suggested a compromise could be considered by reinstating collection bi-weekly or even monthly. The Township should try to maintain a good relationship with the public by being accessible, welcoming and providing good service. She also noted that the street sweeper created a great deal of dust in town and maybe the water was not put in when cleaning occurred this spring.

Alvery Hayes - Noted some issues of his own pertaining to trees blowing over into the river, 5 elm trees that are dead near his property and property standards issues in Lucknow near his home at 578 Inglis Street.

The Mayor noted that the delegation was over the time limit and he was deviating from the request to speak on yard waste. Alvery proceeded to speak on the collection of yard waste. He noted that many will now have to pay private business to remove yard waste. He noted that no notice was sent out to the people of Lucknow about the removal of the yard waste pick up.

Action: Council thanked them for the information and noted that yard waste collection is a budget item. Council is requesting the Director of Public Works prepare a report that will provide budget numbers on re-implementing this service

in Lucknow or variations to the original service and the further option of implementing it in all urban areas of the Township.

4.2 Saugeen Mobility and Regional Transit (S.M.A.R.T.) 7:10 p.m.

Roger Cook, Manager will be attending to provide an update to Council.

Staff Comments: The report has been attached for Council's review.

Action: Mr. Cook noted that ridership was up 12.06% totalling 33941 rides from 30287 rides in 2014. Rides are \$2.00 per ride plus \$0.50/km with \$7.50 being the minimum per ride. They now have 48 registered clients including Pinecrest Manor in Huron-Kinloss.

WHEREAS Ontario is a major hub of human trafficking in Canada, and victims are lured, manipulated and coerced, often over the internet from every part of Ontario; and

WHEREAS human trafficking is in our neighbourhoods and our communities;

THEREFORE be it resolved that the Township of Huron-Kinloss Council hereby supports Bill 158, *Saving the Girl Next Door Act, 2016,* and in so doing supports MPP Laurie Scott's motion for a multi-jurisdictional and coordinated task force of law enforcement agencies, Crown prosecutors, judges, victims' services and frontline agencies
