The owner is aware of the requirements in the Animal Control and Kennel Licencing By-Law and a Kennel Licence will not be issued until the existing building is renovated and satisfactory to house dogs according to the provisions in the by-law.

The By-Law will permit up to 50 dogs per Kennel. The number of puppies does not count as long as they are not weaned from their mother. As soon as they are weaned they are included in the kennel number. It will be up to the By-Law Enforcement Officer to ensure the applicant adheres to the By-Law.
