Being a By-Law to Adopt the 2020 Municipal Annual Budget
for the Township of Huron-Kinloss

WHEREAS Section 290 of the Municipal Act, 2001, S.O. 2001, c. 25 as amended requires that a local municipality shall, in the year or the immediately preceding year, prepare and adopt a budget including estimates of all sums required during the year for the purposes of the municipality;

AND WHEREAS The Council for The Corporation of the Township of Huron-Kinloss deems it expedient to adopt the annual estimates for operating and capital purposes for the Township;

NOW THEREFORE the Council of The Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 That The Corporation of the Township of Huron-Kinloss Council hereby adopts the 2020 Municipal Budget as contained in the attached Schedule "A" to this By-Law .
- 2.0 This By-Law shall come into full force and effect upon final passage.
- 3.0 This By-Law may be cited as the "2020 Budget By-Law".
