Being a By-Law to Amend By-law No. 2022-185; being the Consolidated
Appointment By-Law
for The Township of Huron-Kinloss

WHEREAS Sections 9 to 11 of *The Municipal Act*, S.O. 2001, c. 25 as amended provides broad powers to municipalities to establish By-Laws to govern the structure of the municipality and its local boards;

AND WHEREAS *The Municipal Act*, 2001, as amended, further provides the authority to provide for accountability and transparency of the municipality and its operations and of its local boards and their operations, including but not limited to the health, safety and well-being of persons, services and protection of persons and property, including consumer protection;

AND WHEREAS the Council of the Corporation of the Township of Huron-Kinloss passed By-law No. 2022-34 being the Consolidated Appointment By-law to appoint members and council representatives on various committees and functions for the purpose of carrying out the general business of the municipality;

AND WHEREAS the Council of the Corporation of the Township of Huron-Kinloss deems it desirable to amend By-Law No. 2022-34 in regard to committee appointments;

NOW THEREFORE the Council of The Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 That the Appointment of persons and council representatives on various committees and functions shall be designated in Schedule "A" and Schedule "B" attached hereto and forming a part of this By-Law.
- 2.0 That By-law No. 2022-98 is hereby repealed.
- 3.0 This By-Law shall come into full force and effect upon final passage.
- 4.0 This By-Law may be cited as the "Council and Committee Appointment (2022-2026) By-Law".
