Pilot Program Recap

- With support from Impact Canada's Food Waste Reduction Challenge, a pilot program was run Bruce County that included 880 participating households, 420 of which were supported by the MIC.
- Net cost to the Municipal Innovation Council was \$42,000 + Shipping + HST
- Program ran from May August 2023
 - Usage was tracked for 12 weeks to calculate total waste diversion.
 - Participants completed a survey to provide data and feedback.




- 691 responses collected out of 880 participants (78.5%)

Prior to using the FoodCycler, how did you dispose of the majority of your food waste?






Why don't you compost?

Average of **3.70 cycles/week** for FC-30 (2.5L)

Average of 3.78 cycles/week for Maestro (5L)

Equivalent ~277 kg/year/household or ~11.7lbs/week/household

Residents reported generating 0.42 fewer standard garbage bags per week, a reduction of 21.8 garbage bags per household per year being trucked to local landfills!



"My garbage **reduced** to 1 regular bag every 3 weeks-ILOVED THIS MACHINE!" - Resident from Saugeen Shores

"So far it has **cut down on my garbage dramatically**. From one bag a week to one every two or three weeks. Providing these to permanent residents could be used to move to every two weeks collection for those with one. Or a break on taxes if you do." – Resident from Northern Bruce Peninsula



420 FoodCyclers subsidized by the MIC will divert 116.3 MT of food waste from local landfills per year, the equivalent reduction in greenhouse gas emissions of taking 29.3 gasoline-powered vehicles off the road every year!




Did increased awareness of food waste motivate you to waste less food?





Was the FoodCycler sufficiently large for the quantity of daily food waste you generated?






Did you see increased electricity costs during the time you used the FoodCycler?







If the municipality continued to offer a FoodCycler to residents at no or low cost as part of a diversion program, do you think your friends / neighbours in the community would participate?










Do you live in an urban community or rural area?






Do you currently use the 'pay as you throw' program of bag tags?






Would you pay for organic collection if it was at the end of your driveway?

Pilot Participant Comments

"It is a good option, especially for households like ours that are already composting. May be more of an adjustment for those that currently don't compost"

"Recommend a municipal drop off for compost and yard waste"

"People just need time to get used to doing something new. I would rather cycle my food waste when it was convenient for me rather than have one more bin to take to the road each week. I would probably have used the FoodCycler more but I was away at least half of each week during this test period"

"I was pleased to get the FoodCycler at a reduced rate. However, I think low income families would be still find it an expensive option in the current economy."

"Too many weekend/summer residents leave their garbage out already and animals get into it, so the green bins would increase this mess for permanent residents to deal with.

"I don't see curb side organic collection as feasible in this area due to wildlife. Containers would have to be bear-proof which would be cost-prohibitive, unless provided by the municipality."





Recap and Next Steps

Recap

- 116.3 MT of food waste diverted from landfill/year from 420 FoodCyclers subsidized by the MIC
- Average reduction of **21.8 garbage bags** per household per year being
 trucked to local landfills as a result of
 food waste.
- 97% of participants will continue using the FoodCycler


