BY-LAW

2019-59

Being a By-Law to Authorize the Signing of a Joint Recreation Cost Sharing Agreement with the Corporation of the Municipality of Kincardine

WHEREAS the *Municipal Act S.O. 2001*, c 25, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its council;

AND WHEREAS the *Municipal Act S.O. 2001*, c 25, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9; shall be exercised by by-law;

AND WHEREAS The Council for The Corporation of the Township of Huron-Kinloss deems it expedient to enter into a joint recreation cost sharing agreement with the Municipality of Kincardine;

NOW THEREFORE the Municipal Council of the Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 That the Township of Huron-Kinloss hereby enters into an agreement with the Municipality of Kincardine which is attached as Schedule "A" and forms part of this By-law.
- 2.0 That the Mayor and Clerk are hereby authorized to sign on behalf of the Council for The Corporation of the Township of Huron-Kinloss, any documents required and to affix the corporate seal of the Township of Huron-Kinloss.
- 3.0 This By-law shall come into force and effect upon its final passage.
- 4.0 This By-law may be cited as the "Huron-Kinloss and Kincardine Recreation Agreement By-law"

THIS AGREEMENT made this 15 day of April, 2019

BETWEEN:

THE CORPORATION OF THE MUNICIPALITY OF KINCARDINE, Hereinafter called "Kincardine"

OF THE FIRST PART

-and-

THE CORPORATION OF THE TOWNSHIP OF HURON-KINLOSS, Hereinafter called "Huron-Kinloss"

OF THE SECOND PART

WHEREAS Kincardine and Huron-Kinloss wish to enter into a Joint Recreation Cost Sharing Agreement;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the sum of Two (\$2.00) Dollars of lawful money of Canada now paid by Huron-Kinloss to Kincardine, the receipt whereof is hereby acknowledged, and in consideration of the sum of Two (\$2.00) Dollars of lawful money of Canada now paid by Kincardine to Huron-Kinloss, the receipt whereof is hereby acknowledged, and in consideration of the following further mutual covenants, the parties agree as follows:

- 1. Upon a mutual agreement by both parties recreational services will be provided to all residents of Huron-Kinloss on a year round basis, with the same rights and privileges as the residents of Kincardine.
- 2. In consideration of the above rights bestowed in Section 1, Huron-Kinloss shall financially remunerate to Kincardine yearly amounts commencing with base amount for 2020 of \$83,000 plus 2019 Ontario Consumer Price Index to a maximum of 3%. Thereafter, the previous year payment shall be increased each year by \$3,000 plus the Ontario Consumer Price Index for the previous year to a maximum of 3%.
- 3. The amounts outlined above shall be paid annually in four equal quarterly installments.
- 4. This agreement shall commence January 1st, 2020 and terminate December 31st, 2024.
- 5. Both parties agree to review this agreement in 2023, one year prior to the natural termination of this agreement in 2024.
- 6. Either party may terminate this agreement by providing upon 1 (one) year written notice to the other party.
